

MID-YEAR CHECK UP

July is a great time to reevaluate how your year is going. To see the progress you've made on your goals, or make adjustments to those goals. One way to make sure you are on track financially this year, is to double check your pay-stub. Are you withholding enough (or too much) on your paycheck? Have you experienced a change in your life that could effect your tax status - such as getting married or adding an additional dependent? To get an idea of what you should be withholding, you can use a tool provided by the IRS: [Tax Withholding Calculator](#). It may also be wise to speak with a qualified tax accountant to make sure your withholding is set up correctly.

If a change is needed to your pay check, please submit the necessary forms to your Payroll Specialist to make sure you are on track for the rest of the year.
