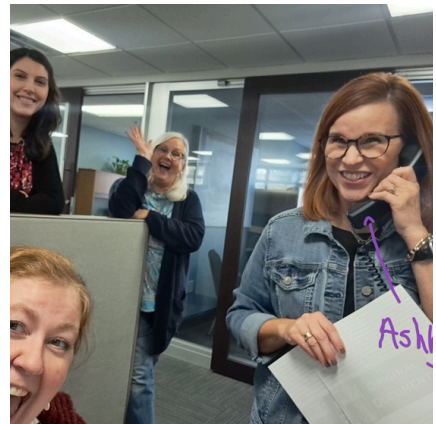

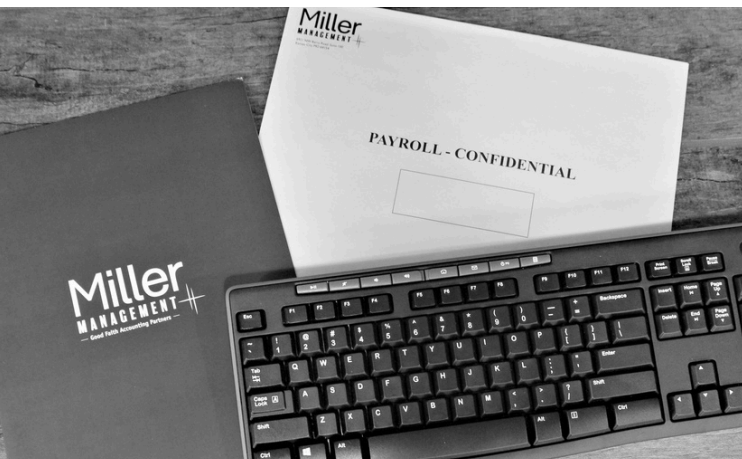
STAFF HIGHLIGHT: SHARILYNE COCHRAN
