PORTAL FOR PAYROLL

How was your W-2 sending this year-end? Was it a little more involved than you thought it might be? Let's try to fix that for next year.

You might find yourself in one of two camps.

Camp #1

And a reminder to strongly encourage new hires to log in right at hiring instead of waiting until year-end next year. 
STAFF SPOTLIGHT
