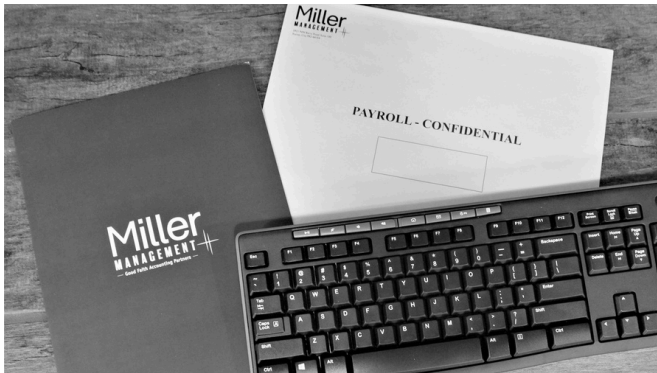
STAFF SPOTLIGHT
